




Activity field II ("Tasks & Solutions")

Activity field I ("Public Voice")

Public Voice @IDSA consists of different formats/channels:

Impulse Papers First ideas, concepts, opinions regarding upcoming topics and developments to stipulate further discussions ("first mover/teaser approach")

Position Papers

 Ideas, concepts, opinions regarding specific topics/existing discussions or to answer inquiries/requests to position IDSA ("positioning approach")

- Format: Articles published on IDSA website (pdf download), internal sources and mailing to members
- **Content**: Based on different templates considering the different approaches (e.g. Impulse Papers should mainly consist of teasers, *"rather questions than answers"* while Position Papers should consist of clear statements (can also include IDSA member surveys/interviews, *"rather answers than questions"*)
- **Organization**: Editorial schedule to be drafted (including possible topics for papers, deadlines (how often should papers be published?, definition of workstream etc.)



Interoperability of data spaces by "common terms"

- Introduction: "common terms" does not only mean the consolidation of terms between different regulations (this seems to be already an issue considering the different definitions proposed by the different EU Acts like DGA, DA-E), but (1) between such regulations with already existing initiatives and (2) such initiatives in relation to each other
- DGA and IDS RAM (example: data intermediation services)
- Why we need "common terms"
- Compare of existing terms (DGA, IDSA, Gaia-X, Others)
- Towards "common terms": How can existing terms be aligned? What existing glossaries can be used/are out there? [DSSC as an example]

Hot Topics (addressed by Working Groups)

- 1. What would be the legal enforcement of IDS if the case is taken into a court?
- 2. What kind of legal enforcement can be put into action, when you join and/or leave a data space?
- 3. How the transition from technical legal agreements to real-life contracts be possible (contracts that are signable by real people)?
- 4. What would a legal interoperability framework for a data space consist of? (what kind of framework? Business, technical, etc..)
- 5. Current regulation applicable to a data exchange. Our thought was that when you're buying something, let say an ice cream, you're not signing a contract, but you're relying on some legal basis (let say contract law for instance) protecting the stakeholders, freeing them to remind all the rules appliable to such transaction (since they are implied by the regulation). Hope this is not a too naïve view. But then what would be those current (implied) rules appliable to a data exchange? And where are the gaps we should pay a special attention to include in the contract to protect the stakeholders?
- 6. Create an IDS contract for data exchange (covering the transaction process especially)
- 7. Map ODRL language with a standard contract to identify gaps
- 8. Liability of the different stakeholders to a data exchange in an IDS environment
- 9. Data ethics
- 10. What's the role of IDS on legal matters: what is the position, which guidance will IDS provide, not just related to setting the legal agreements but also in case the parties are not adhering to them?
